Summary

1. Amends sections 7-16, 7-17, and 7-18 of the Georgetown Code of Ordinances to update the NFPA Fire Code and Life Safety codes from the 2006 version to the 2012 version.
2. Provides for severability of provisions and an effective date upon passage and publication.



ORDINANCE NO. 14 - 016

AN ORDINANCE ADOPTING THE 2012 NFPA FIRE SAFETY AND LIFE SAFETY CODES

SPONSOR: Council Member Connie Tackett

WHEREAS, the City of Georgetown has, by ordinance, adopted the 2006 Standard of Safety and the National Fire Safety and Life Safety Codes, and

WHEREAS, the Commonwealth of Kentucky, Department of Housing, Buildings and Construction has adopted the 2012 NFPA 1 Uniform Fire Code and NFPA 101 Life Safety Code, and

WHEREAS, the City desires to update its NFPA standards by adopting the 2012 NFPA 1 and 2012 NFPA 101;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF GEORGETOWN:

Section One

Section 7-16 of the Georgetown Code of Ordinances is amended as follows:

The Kentucky Standards of Safety (Fire Prevention Code) as promulgated in 815 KAR 10:060~~(4)(b)(1) and (2)~~ by the ~~d~~Department of ~~h~~Housing, ~~b~~Buildings and ~~e~~Construction on the advice and recommendation of the state fire marshal, is hereby adopted and incorporated by reference as set forth in said regulation excluding those standards which are excluded by state regulation as an ordinance for the city. Copies of the code book are available through the department of housing, buildings and construction, 101 Sea Hero Road, ~~100~~Suite 100, Frankfort, Kentucky 40604-5405, or a copy may be reviewed at the office of the City Clerk, City of Georgetown.

Section Two

Section 7-17 of the Georgetown Code of Ordinances is amended as follows:

The ~~2006~~2012 NFPA 1 Uniform Fire Code and NFPA 101 Life Safety Code copies of which are on file in the office of the chief of the city fire department and at the office of the City Clerk, City of Georgetown, are hereby adopted and incorporated by reference as set forth in 815 KAR 10:060~~(4)(b)(1) and (2)~~ as an ordinance for the city, said ordinance being incorporated herein by this reference.

Section Three

Section 7-18 of the Georgetown Code of Ordinances is amended as follows:

The fire chief shall be designated as the local enforcement agent for the above Standards of Safety and the Nation Fire Codes, 2006~~12~~, as appointed by the state fire marshal and the city.

Section Four

If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unlawful by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.

Section Five

This Ordinance shall become effective upon passage and publication.
